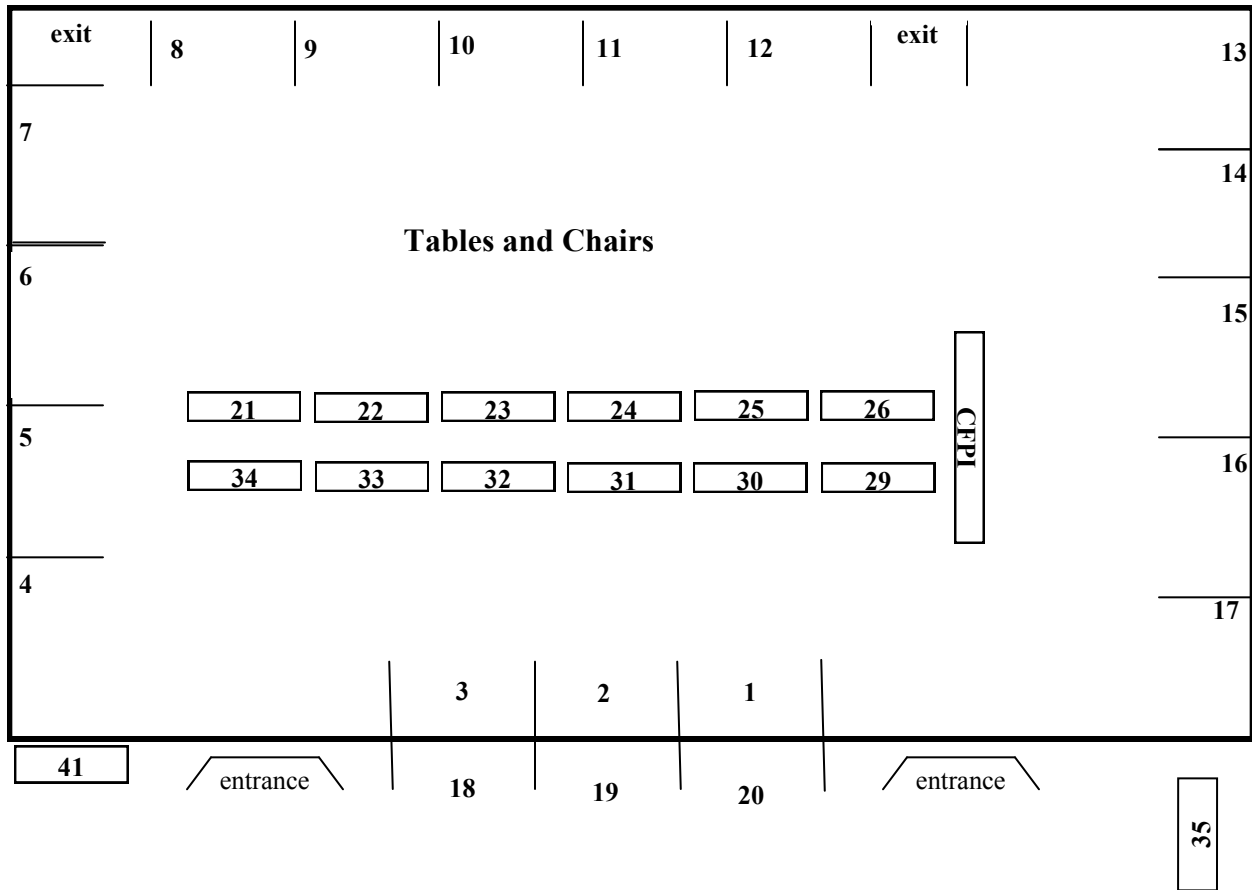


Fire Safety Exhibit Hall Layout

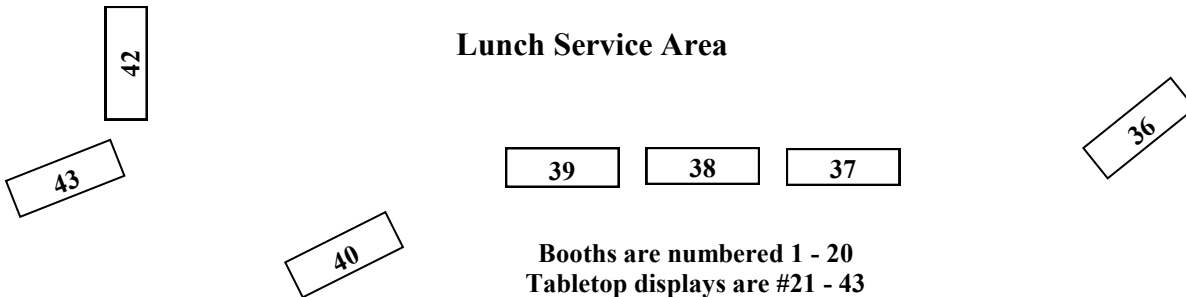
